USER CONTEXTS

Understanding diverse user needs, including disabilities and beginners, is crucial for creating accessible experiences. This involves leveraging assistive technologies, various devices, and considering external factors like lighting and connectivity.

Users

 Sensory disability, motor disability, cognitive disability, temporary disability, seniors, beginners, etc.

Assistive technologies

 Braille displays, screen readers, virtual keyboards, trackballs, etc.

Equipment

 desktop, laptop, tablets, smartphones, browsers, software, user settings, etc.

External factors

 mobility, lighting, noise, connectivity, etc.

USER IMPACTS



Defining user impacts helps prioritize issues based on their severity, ensuring critical accessibility barriers are addressed first.

This approach aligns with RGAA standards to enhance web accessibility and user experience for all

Blocking

Inability to access content and features.

Major

Usage is difficult and complicated.

Minor

Needs correction but has a lower user impact.



ACCESSIBILITY AUDIT RESULTS

French regulations conformity

Percentage of Criteria Met = C / (C + NC)

C represents the number of compliant criteria. NC represents the number of non-compliant criteria. (C + NC) represents the number of applicable criteria.

Compliance rate

Validated Criterion: A criterion is validated if it is confirmed on all sample pages. If it is invalidated on even one page, it cannot be considered valid for the rate calculation.

Applicable Criterion: A criterion is considered applicable if it applies to at least one page in the sample.

Non-Applicable Criterion: A criterion is non-applicable if it does not apply (due to non-existent content or functionality) on all sample pages without exception.





- Targeting **redundancy** in non-compliance

Unreachable content via keyboard




RGAA Criterion: 7.3

Problem: [Header > Departments > Left Menu] The buttons and links in the left menu are not accessible via keyboard.

User Impact: Affects individuals navigating with a keyboard, such as visually impaired users utilizing a screen reader.

Solution: Make the menus accessible via keyboard.

RGAA Criterion: 10.12

Problem: [PDP] The text "Select your size" is truncated

User Impact: Affects individuals with cognitive impairments

(e.g., dyslexia).

Solution: Ensure the text is not truncated.

Information conveyed by form only




RGAA Criterion: 10.9

Problem: A link conveys information through its form but not through code.

User Impact: Affects visually impaired individuals using screen readers.

Solution: Add code-based information to the active link using the attribute aria-current="page".



Information conveyed by form only




RGAA Criterion: 10.9

Problem: A link conveys information through its form but not through code.

User Impact: Affects visually impaired individuals using screen readers.

Solution: Add code-based information to the active link using the attribute aria-current="page".



Absence of quick access link




RGAA Criterion: 12.7

Problem: Lack of at least one quick access link to the main content of the site.

User Impact: Affects visually impaired individuals using screen readers.

Solution: Add a quick access link to the main content of the site, which can be visually hidden and only displayed when focused via keyboard.

Indistinguishable link



RGAA Criterion: 10.6

Problem: The links in the footer are not clearly visible.

User Impact: Affects everyone.

Solution: Ensure the link is distinguishable from surrounding text by either underlining it or ensuring the link color has a contrast ratio of at least 3:1 compared to the surrounding text, and that it has a visual indicator on hover and focus beyond just a color change.

Solution: Follow valid HTML markup
